The ARC propose that WOU change the graduation requirements for undergraduates as follows:

Current catalog: Complete a minimum or 180 credits, including at least 62 upper division credits.

Proposed revision: Complete a minimum of 180 credits, including at least 60 upper division credits. The 60 upper division credits will not be waived as a graduation requirement.

Rationale for this proposed change is as follows:

- 1. Faculty have had multiple advisees who needed to take an extra upper division course simply to meet the 62 upper division (UD) credit graduation requirement; i.e., all of their other degree requirements were fulfilled—they had completed over 180 credits of course work, the requirements for a major, and the requirements for a minor. The ARC reasons that a student who completes our major, minor, and general education requirements should not also need to take an extra course to meet our UD requirement. Evidence that other colleges and universities share this perspective is that, as described in more detail below, it is not uncommon for colleges and universities to not have an explicit UD credit requirement. At those institutions, students need to meet the general education and major degree requirements, regardless of the number of UD credits contained in the major and gen ed. By lowering the minimum UD credit requirement from 62 to 60 credits, we would reduce an obstacle for students.
- 2. After reviewing graduation requirements at our peer institutions (as listed on the WOU website), the Oregon public undergraduate institutions, and several Oregon private liberal arts colleges. Of the 19 institutions reviewed, 7 do not stipulate a specific number of upper division (UD) credits needed to graduate. Of the remaining 12 institutions, the average number of UD credits required for graduation is 60. Changing our UD credit requirement to a minimum of 60 would bring our curriculum in line with most of our peer and local institutions, without impacting degree offerings. The institutions and UD credits are listed below.
- 3. All of our course offerings are 3-, 4-, or 5-credits. 60 UD credits constitutes 20 3-credit courses, 15 4-credit courses, or 12 5-credit courses. A minimum requirement of 60 UD credits makes more sense with our typical course offerings than does a minimum 62 UD credit requirement.
