Business Meeting

1. Call to order: 15:30

- 2. - 3. Corrections to and approval of minutes from previous meeting
 - No corrections to the minutes
 - Approved as posted
- 4. Institutional Reports
 - 4.1. Adele Schepige, Faculty Senate President
 - 4.1.1. BOT Faculty Trustee election 2/13/18
 - Two faculty members put in statements
 - Want to give divisions chances to discuss these things
 - Motion to forward two names onto Board of Trustees
 - Hoping to interview candidates by February 5th
 - o Elections are about acceptability, are not to pick nominee
 - If were to wait, what date is February meeting?
 - February 6th
 - Next Faculty Senate meeting is the 13th
 - Board would like to start on February 5th
 - Governor requires 6-8 weeks
 - February 5th allows Board chair to interview
 - Wouldn't have confirmation until September if pushed back
 - Modified motion: These two candidates are acceptable and names will be forwarded to Board of Trustees
 - **Motion passes**
 - Comment: Can email discussion to divisions happen?
 - Comment: Just forward names as acceptable to Board, Board does own review process



- Senators were elected; they represent divisions
- Comment: People may not have looked at materials for each of the candidates
 - Comment: If there was some sort of red flag, wouldn't Governor and legislature see as well?
 - Comment: Chair of Board will interview both candidates
- Faculty Senate's Role is simply to say they find both candidates acceptable
 - Comment: Individuals on other campuses who do not have faculty roles get nominated as faculty perspective
 - Comment: Faculty Trustee is not representing anybody
 - Faculty Trustee brings own perspective as faculty, not representing faculty, but as an individual
- 4.2. Rex Fuller, University President
 - 4.2.1. Ryan Hagemann, Legislative Update and Lobby Day
 - Tomorrow is the day to review all the bills that were dropped
 - O Awaiting results of measure 101 election tonight
 - o If 101 fails, legislature will be facing money hole
 - Position: Not one penny removed from public university support fund; if 101 fails and the legislature turns to university support fund, all bets for limiting tuition increase promises off
 - February 15th University Lobby Day
 - o Needed \$100 million, now need \$130 million
 - \$30 million due to PERS assessments
 - Expecting payroll assessment on top of PERS assessment to make up for
 - o Anticipate budget deficit of 1.2 billion dollars for 2021
 - Legislature and University funding tense:
 - will be confronting Oregon state Cascades—want to build building in Bend
 - University of Oregon asking for \$40 million
 - o Compared to Eastern Oregon asking for \$9 million
 - Small campuses decided to hire outside lobbyist
 - o Only to lobby things on which all four agree
 - Council of presidents want to provide unified front
 - May not be possible this time
 - Tuition bill in session sponsored by a student group
 - o Multiple problems
 - Likely unconstitutional
 - o Likely would destroy bond credit ratings of universities with bonds
 - Cuts University president out of recommending tuition
 - o Oppose bill, don't think amendment would be satisfactory to save bill
 - Technical fixes to DACA portion of statute
 - Assessment based accelerated learning bill
 - o Comes from Willamette promise disagreements
 - Will not oppose withdrawal of bill
 - To continue promise of Willamette promise credits
 - o Have tried to come to agreement



- 4.3. Stephen Scheck, University Provost
 - Public announcement Emeritus faculty application policy will go out for public comment
 - Went through first review recently
 - This is an opportunity to do further editing
 - House Bill 2998
 - HECC is seeking specialists in English, Education, Business, and Biology from all universities
 - What would be best 30 credits for transferring
 - Will check in with deans
 - HECC would like to have these people identified by tomorrow
 - HECC works on 12-month calendar
 - Opportunity for Early Retirement Closed last Friday
 - Searches
 - If in program, need new tenure track lines to start in fall, communicate to your dean
 - Use the standard paperwork for search for new
 - Paperwork will be given expedited review
 - President and Provost will be looking at all of these
 - Gen Ed committee working on General education program director announcement and qualification and duties
 - With evolution of new Gen Ed curriculum, need more director power than Gen Ed committee can do with meeting of faculty senate committee
 - o Will be working closely with deans and Gen Ed committee
 - Provost Town Hall Meeting: academic budgeting [See <u>Provost's Town Hall</u> Summary]
 - Intertwines academic strategic planning and budget planning
 - Faculty generate overwhelming share of revenue that comes into this institution
 - Streamlining pathways to degree completion
 - Need to get students to finish line
 - Keeping a student in college gets as much money as going out and finding new one
 - Support academic excellence
 - Have much more transparency
 - What kind of criteria used for assessing
 - Is important faculty have good understanding
 - o In supporting university budget committee process, want to make information much more readily available so not as much confusion
 - Must deliver academic strategic plan by end of year
 - o Very intensely in phase of doing academic strategic plan
 - Will bring to faculty senate for more refinement
 - o Will be map for how funds are allocated
 - Preview Day next Saturday (February 3rd)
 - Question: where will emeritus application policy be posted?
 - o Policy council website



- 4.4. Tad Shannon and Erin Baumgartner, Interinstitutional Faculty Senate
 - HECC Workgroup Last Friday
 - o Commission approved staff draft report
 - o Briefing legislators on all that has been accomplished
 - HECC staff is pressing for recruits
 - Told they'd already missed catalog deadline for some colleges for foundational curriculum
 - Implementation going to be an issue
 - Not clear what will happen next
 - Will have another work group meeting soon
 - Regardless of consensus, HECC staff addressing House Bill 2998
 - WR 122 an issue
 - Need to form workgroups but need more discussion on how it works
 - What has been proposed is not bad, details just need to be hammered out
 - o Courses identified as safe courses fit very well
 - o Did have full meeting last session
 - Very important that role of senate across the state start taking up role of curriculum, be strong voice of curriculum
 - Good discussion about trying to increase effective communication with community college colleagues
 - Will be some cross visiting between IFS and OEACCC meetings in order to combine two groups
 - o Continued discussion regarding student evaluation of teaching
 - Will put forth revamp of student evaluation of teaching
 - Once put forward, will offer to other IFS members
 - Some have voted to suspend student evaluation until come up with something better
 - o Student success, funding models
 - o Oregon State University created online delivery service

6. Consideration of New Business

- 6.1. Required Minor, Stephen Scheck, University Provost
 - Requested rationale for optional minor be put into curricular pathways
 - o Creating minor optional enhances 180 credit degree
 - Have option to pursue minor if want to
 - In document, 5 most common statements questioned or described over last 9 months
 - Minors are mark of distinction at WOU
 - Is incongruent with admission
 - Minors necessary to ensure students broaden educational experience
 - If students aren't guided to take minor, will take unguided coursework and waste educational opportunity
 - If student wishes to explore varying discipline, all courses are worthy courses



- Rests heavily on advisor
- Required minors bolster enrollment in low enrollment departments
 - In 2015-16, 9 of the 15 LAS minors delivered by 8 highest enrollment programs
 - Students taking degree minors in aligned areas to what majors are
- Catalog will urge students to consider minor
 - Programs still have right/ability to require minor
 - Build into 90 credit unit quota set aside for degree program
- Double Majors
 - Question: If students want to double degree, have to have a minor, what will happen to that?
 - If degree program requires minor, and student chooses to double major in something that has required minor, is more of a "buyer beware"
 - O Question: When student is double degreeing, have to have minor
 - Would be no required minor unless one of those degrees requires minor
- Data indicated minor did not cause slow down or excess number of credits for graduation
 - o Showed for every additional requirement, extended credits
 - What's holding students up is finishing minor requirements
 - For any students with over 200 credit units, has completed Gen Ed requirements, will waive minor if only requirement left
 - Students can still minor
 - Cost to students rapidly rise
 - WOU tuition is second lowest, but we are one of most of the expensive schools to get a degree from
 - No place to have electives
 - Many have unused electives that hold them up
 - Is to increase chance student will be retained
- Comment: With Veterans benefits, unless something absolutely listed as required in program, will not be covered—will minor be covered?
 - o Is like financial aid
- 6.2. Educational Interpreting Certificate, Sarah Hewlett, DSPS

Research Certificate, Elisa Maroney, DSPS

Professional Practice Certificate, Vicki Darden, DSPS

- Interpreters required to maintain certification
 - o Academic units are simple way to do it
 - o Automatic
 - o 60% of people surveyed interested in certificates
 - Hopefully will hook in and get masters
- Educational Interpreting
 - Highest employer of graduates
- Professional Practice
 - New way to assist interpreters
- Research
 - Second highest interest
 - o Field is fairly new, not a lot of research out there

7. Discussion Item

- 7.1. Community College Agreements, Carol Harding, Humanities Chair
 - There was a transfer agreement that included a course from humanities division without humanities knowing about it
 - Need protocol for transfer agreements
 - This would set up chain of events that should occur as these are developed
 - As soon as discussions begin, WOU faculty, any department whose classes are involved, will meet to discuss proposal
 - Will then be routed to divisions and deans
 - Suggestion: All transfer agreements—all divisions whose classes involved must be consulted and signatures listed on agreement
 - Comment: Some institutions where curriculum committee has to look over all new articulation agreements
 - Variety of models of how faculty engage with articulations
 - o Will become an issue, will have regular statewide articulation agreements
 - o At some point will have to formalize process
 - Comment: Sometimes divisions have had issues with representation on committee
 - o If dean signature is there, assumes faculty have been consulted
 - o Recommend to also have division chair sign as well
 - Comment: Issues with doing this with an AB degree
 - o Part of articulation degree would include core of AB degree
 - May make nearly impossible to coordinate
 - Not transfer programs, terminal two year degrees
 - Comment: What about the primarily paperless documentation vote?
 - o Is 2018, have faculty senate curriculum programmer
 - o Curriculum committee—complex and technical issues need to be reviewed
 - Could go through curriculum committee and through faculty senate committee
 - Could go on to deans
 - Would be assured all players have opportunities to look
 - Would be in public
 - Wouldn't need signatures
 - Comment: PSU has created handbook
 - Could get permission to utilize handbook
 - Need process
 - o Make sure up-to-date
 - Have some coming up for renewal
 - Could keep spreadsheet
 - At end of day would like website with big spreadsheet
 - Could make sure deans informed
 - Question: If have two or three different departments involved, how would make sure initial discussion happened at all department levels?
 - If goes through curriculum committee and faculty senate and then deans, much stronger chance will be seen
 - o Before even gets to portal, want all departments informed
 - o Agreements have to be signed by people at community college and here
 - At some point will be paper
 - Think is mechanism in curriculum committee portal, have to have



already had conversations

- Stays consistent with how deal with curriculum changes
- Bring to general faculty, don't just keep to one division
- Question: At what level would it be entered into portal?
 - Could a proposal be entered in straight at curricular level?
 - Variety of people in curriculum guidelines able to put in curricular proposals
 - Any transfer agreement takes a fair amount of time
 - All involved members informed
 - Won't happen like curriculum proposal
 - Can be conduit between other colleges and WOU in terms of partnership
 - Would then move forward, doesn't happen overnight, is a time period
 - Don't want to create agreements faculty not okay with
 - Just want to make sure administrative and faculty staff at table before agree to any agreements
 - Having central point can make sure conversations are happening
- Comment: Transfer agreements do not have consolidated home
- Comment: Whatever process come up with, not too lengthy
 - Will lose opportunity to partner with some of these programs
- Comment: Talked about large population coming from transfers, need to be transfer friendly
 - o Nervous about individual departments not wanting articulation agreement
 - o Think is important to be talked about on curricular level
- Comment: Issues around existing articulation agreements
 - Want to understand some of the technical things
 - o Need to have established policy all understand
 - As long as transparent, consistent protocol
- Comment: Executive Committee will work on this

8. Informational Presentations and Committee Reports

- 8.1. Quantitative Literacy PLC findings, Breeann Flesch, QL PLC Chair [Memo, report, and PPTX on faculty senate site]
 - Year-long process
 - Readable report
 - Contact her or use the link if you'd like a copy
 - o Will continue conversation throughout year
 - Use AACU definition of Quantitative Literacy
 - Rubric has levels that equate to first time, second time and so on with experiencing Quantitative Literacy
 - Good Quantitative Literacy would focus on two or three points
 - Goals
 - o Examine level of WOU undergraduate Quantitative Literacy
 - Figure out PLC process
 - Lot of logistical questions had to figure out
 - Process
 - o Identified courses and instructors teaching courses



- Sent out call for student work
- Uploaded assignments to Moodle
- o Reviewed student work
- o Discussion of non-concurrence
- o Aggregation of data from review
- o Discussion and recommendations to Gen Ed, AFSC and campus
- Identified 42 QL aligned courses
 - o Includes Q designated courses
 - o A lot were math and science courses
 - o Received samples from 27 courses
 - o Part of goal this year was to get word out about process
- Application, Calculation and Representation well represented at WOU
 - o Communication, Assumptions and Interpretation not as well represented
 - Concentrated on General Education
- Students mostly meeting expectations
- One assignment with one typical student work was sufficient
 - o Felt gave enough information to say important things
 - Needed to have instructors communicate
 - Need to be a little more explicit
 - Had a process for opting out, helped reviewers feel comfortable with process
- QL: Right alongside content, authentic examples
 - Would like to see more assumptions
 - o Could be sampling method
 - Next time could put out more dedicated sample
 - If not a thing WOU does well, need to ask whether is important thing or if rubric should be amended
- Assessment Facilitation steering committee will be hosting conversation in February about this
 - o Will be email forthcoming
- Move to extend meeting by five minutes; passed
