By offering a certificate program in Interpreting Studies: Teaching Interpreting, Interpreting Studies: Research], the division seeks to address the need that interpreters and interpreter educators nationwide have for professional development. Each certificate package may be applied to the MA in Interpreting Studies, if students wish to pursue a degree.
