Summary/Rationale for proposal

The Graduate Certificate in Social Justice provides students with an avenue for addressing social justice issues by focusing on skills related to advocacy, policy, and research in the administration of justice. The curriculum will expose students to a variety of social justice components and issues, while helping them progress toward scholarly work that allows them to focus on their individual areas of concern and passion. Students will learn strategies for conducting consequential research, evaluating and shaping policies and practices, and seeking and affecting change by addressing complex social challenges.

Students will be prepared for careers in community organizing and advocacy, criminal justice, research and policy centers, NGOs, public and private agencies, and nonprofit leadership, or to progress in their current place of employment. In addition, completion of this certificate will allow students to enter the Master of Science in Justice Studies at WOU to complete their graduate degree in just one additional year if they should so choose.

This graduate certificate is timely in light of recent events including nationwide and global protests concerning police brutality, white supremacy, and systems of oppression. Student interest in how to address these topics and make substantive and lasting change is peaked. The graduate certificate is being proposed alongside a new master%u2019s program as a faster route for students not seeking a full master%u2019s degree and those who want to earn an accommodation in a shorter time frame.

In the initial planning stages for the proposed program, we spoke with multiple state and local agencies that address criminal and social justice issues to gather their feedback and interest. These included the Oregon Department of Corrections, Oregon Youth Authority, FBI Portland Office, National Crime Victim Law Institute, Lewis and Clark Law School, Oregon Justice Resource Center, Youth Justice Initiative, Light My Way Ministry and Reentry Program, CREATE Programs, Resolutions Northwest, Partnership for Safety and Justice, Multnomah County Probation and Parole, Washington County Community Corrections, Washington County District Attorney, Washington County Sheriff%u2019s Office Jail and Patrol, and Washington County Drug Court. Each of these organizations, agencies, and future employers of WOU graduates confirmed the need for such a program to advance the knowledge and abilities of their application pool and existing employees.

This new graduate certificate broadens the current Criminal Justice Sciences Division%u2019s graduate program offerings to meet the diverse and evolving needs of students. CJS currently offers the Master of Arts in Criminal Justice which emphasizes criminal justice in the applied areas of the administration of justice and crime control. This certificate, on the other hand, will allow us to appeal to those who plan to be activists, and change agents seeking to positively impact various social justice arenas but are not looking to complete a full master%u2019s degree program.

At WOU, we are proposing multiple graduate certificates %u2013 Advanced Juvenile Justice Studies, Conflict Resolution, and this one in Social Justice. Each of these certificates complement one another and our existing master%u2019s program (Master of Arts in Criminal Justice) as well as our proposed new master%u2019s program (Master of Science in Justice Studies).

All of the public Oregon universities have at least one undergraduate program that will prepare students to continue their education with these graduate certificate programs at WOU. Of the seven state universities, only three offer somewhat related graduate certificate programs, however none of these programs directly compete or compare with any of our proposed graduate certificates.

Portland State University offers graduate certificates in Conflict Resolution; Gender, Race, and Nations; Nonprofit and Public Management; and Social Innovation and Social Entrepreneurship. University of Oregon offers a graduate certificate in Nonprofit Management. Southern Oregon University offers graduate certificates in Cultural Resources Management, Nonprofit Management, and Sustainability Leadership.

Programs affected/consulted

This graduate certificate will potentially bring in students who believe they do not want to complete a full master%u2019s degree, but who may be converted to that option once completing the certificate. As a result, this certificate will likely increase admission into the Criminal Justice Sciences master%u2019s degrees.

Briefly describe how the proposed program meets regional or statewide needs and enhances the state%u2019s capacity to improve educational attainment in the region and state

In 2010, the president of the Academy of Criminal Justice Studies called for the advancement and broadening of the discipline of criminal justice and criminology[1]. %u201CBy complementing criminology and criminal justice with *Justice Studies*, we include the other explanations needed (political, economic, legal, administrative, etc.) to address the relevant issues within our discipline.%u201D As higher education becomes more interdisciplinary in nature to meet the demands of an ever-evolving job market, a student body that expects and deserves a high-quality and valuable education, and institutions become increasingly financially strained[2], the Graduate Certificate in Social Justice meets needs across several areas. This program is also especially timely in light of recent events including nationwide and global protests concerning police brutality, white supremacy, and systems of oppression. Student interest in how to address these topics and make substantive and lasting change is peaked.

The certificate program will be deliverable fully online, making it accessible to a wider and more diverse student population. Students in the certificate program will learn from experienced faculty not only in courses, but by participating in research and in community action opportunities. The Criminal Justice Sciences Division has a history of partnering with multiple state and community organizations to enhance our students%u2019 experience through hands-on learning to the benefit of the community. Taking action to better society is at the heart of the certificate program and can only be learned by doing.

What is the plan to recruit students to this proposed new program? Have you worked with MarCom to establish a marketing plan to promote this new program? Please briefly describe the plan.

The new graduate certificate will be promoted to current undergraduate criminal justice students initially during a special Juvenile Justice Week in Fall 2020 that has 3-4 days of special virtual events focused on juvenile justice topics. Students will be attending these virtual events as course requirements, extra credit opportunities, CJ Club events, or for personal interest. During these events, we will be able to tell them about this upcoming exciting new opportunity or this graduate certificate.

CJS will further work with MarCom to develop materials to be shared with community partners who frequently host WOU CJ students in practicums and internships and who also hire our graduates. With the goal of spending as little as possible, all marketing will be done in a guerrilla and shoestring fashion (e.g., creative and cost-efficient).

What is the budget source for the plan to attract new students to this proposed new program?

The entire program will be delivered fully online with the addition of some off-campus activities. The program will draw on WOU%u2019s learning management system (Canvas) for all format course delivery, including instructional and curriculum design support from WOU%u2019s Center for Academic Innovation.

No other staff are required for this program. Existing facilities and LMS are appropriate for this program. WOU already has the facilities, library, and other resources in place to fully support the courses offered.

Will new sections of courses or additional hires be needed to offer this program? What are the faculty salary budget impacts of this proposed new program? Will additional facilities be required?

Faculty in Criminal Justice Sciences are fully qualified to teach the courses in this certificate program, many of which they already do. These topics align with the areas of research and expertise of existing faculty. The certificate program will require the development of five new courses: JS 658, JS 659, JS 629, JS 655 or CJ 5##. The Criminal Justice Sciences Division has adequate resources to deliver the new JS and CJ courses. As the certificate program grows, the CJS Division will consider these areas of expertise with upcoming requests for faculty replacements, supplemented with adjunct faculty with subject matter expertise.
