#### 3. Shared Governance Summit

In the past two years, we've tried to coordinate shared governance meetings on 5th Tuesdays. These meetings have included faculty and staff union presidents, faculty and staff executive committees, ASWOU leadership, and members of the President's cabinet. To make these meetings more predictable and increase attendance, we're going to have them take place on the second Friday of the second month of each term. Our hope is that these meetings will be a place for increased communication and a renewed commitment to shared governance.

The first meeting will take place on Friday, February 12; the topic will be WOU: Salem.

### 4. Student Health and Counseling

During this time of isolation, pandemic, and online learning, many of our students are struggling with mental health. Students are charged a fee of \$145 to access the Student Health and Counseling center. This fee is charged to students at credit one of a face-to-face or hybrid courses. Students can also opt in if they are taking one online course. Students that are taking all online, asynchronous courses will not have access to these services unless they opt-in and pay the fee.

This term, we had 250 students opt-in to these services. Please keep these details in mind in your syllabi statements, so students know how to get the important support they need!

#### **5. Student Questions About Article 15**

We are all stressed and upset about the proposed cuts in the draft Article 15 plan. With the news of these cuts reaching students, many students are reaching out to faculty with questions and concerns about their ability to complete their coursework. Please be kind and thoughtful with our students, so that we don't add to their panic. We want students to remain at WOU. It's important that we reassure them that there is a pathway for them to complete their degrees.

# 6. Responsible Employees, Mandatory Reporters, and Academic Complaints

As much of our professional lives have transitioned to Zoom, it's important to remember that our reporting protocols still cover behavior we witness in Zoom rooms.

Some helpful definitions:

**Academic complaints** can be related to areas such as grading, assignments, syllabus related items, program admission, academic advising, and other course-related conduct that impairs learning.

**Responsible Employees** are those that a student could reasonably believe has the authority or duty to report incidents of sexual misconduct or other student misconduct to the Title IX Officer (Judy Vanderburg). *All faculty are responsible employees*. As such, WOU faculty are <u>required</u> to report any information received about a possible violation of Title IX (sexual misconduct, including assault, harassment, stalking, and partner violence) to Judy. **Mandatory Reporters** are for child abuse. This applies to persons under the age of 18. It is also not tied to our University, specifically; rather, it is an individual obligation we all have simply by virtue of being employed at a university. As such, if any of us see something in the grocery store, the park, or anywhere else, we are obligated under law to report it to DHS or law enforcement. All WOU employees, including faculty, are mandatory reporters!
