Position Summary:

The RMHC graduate program seeks a dynamic, full-time Director of Behavioral Health. This 12-month unclassified professional staff position will collaborate with academic faculty and staff to strengthen partnerships with agencies, stakeholders, and other entities supporting Oregon's behavioral health needs. The Director will also ensure alignment with CACREP standards and identify and cultivate market opportunities to advance the program's mission.

Housed within the Division of Deaf Studies and Professional Studies in the College of Education, the RMHC program serves annual cohorts at Western Oregon University's Salem campus. The Director will be based at the Salem campus, with occasional travel to the Monmouth campus.
