CREATIVE ARTS IFC REQUEST FY23 SUMMARY

The Creative Arts Division is requesting the same amount of IFC funds as allocated in FY22, which was a 9.7% cut from our original ask of \$294,158.

The Music Department has taken their total allotted budget and redistributed funds based on ensemble enrollment, participation, and overall needs of each ensemble. The Music Department is not asking for an increase in overall funding.



CAD 931: BROADWAY/OPERA

\$3,296

Live performance opportunities, masterclasses, guest artists, applying performance to the big stage.

A 10% cut would give us \$2,966 of funding. This would:

- Limit the amount of live shows students could attend (travel)
- Reduce the funding for piano accompanist

A 15% cut would give us \$2,802 of funding. This would, in addition to a 10% cut:

- Reduce our supply budget to create sets and pay auxiliary musicians
- Reduce our advertising and publicity abilities

A 20% cut would give us \$2,636 of funding. This would, in addition to a 10% & 15% cut:

Limit our programming by reducing our royalties budget

A 10% cut would give us \$19,350 of funding. This would:

- Limit our ability to purchase new uniforms for new members
- Reduce our funding for advertising events
- Cut the funding for 1 festival or community travel

CAD 935: GUEST ARTISTS

\$21,384

Local, international, and world renowned professional musicians, concerts, masterclasses, student workers, and open to the public. Free tickets for students.

A 10% cut would give us \$19,246 of funding. This would:

- Cut our funding for 2 guest artists
- Limit student exposure to professional working musicians

A 15% cut would give us \$18,176 of funding. This would, in addition to a 10% cut:

- Cut our funding for 3 guest artists
- Reduce the funding for student wages by not holding as many concerts

A 20% cut would give us \$17,107 of funding. This would, in addition to a 10% & 15% cut:

- Cut our ability to bring in international guest artists
- Limit our ability to bring cultural diversity to campus through the arts

A 10% cut would give us \$19,800 of funding. This would:

- Limit the ability to upkeep instruments and equipment
- Reduce the funding to pay for auxiliary musicians

A 15% cut would give us \$18,700 of funding. This would, in addition to a 10% cut:

- Cut the funding for 1 festival or community travel opportunity
- Cut the funding to purchase 1 new instrument or equipment
- Reduce new programming by limiting our sheet music budget

A 20% cut would give us \$17,600 of funding. This would, in addition to a 10% & 15% cut:

- Cut our ability to rent vans or a charter bus for any travel, and limit us to local areas only

CAD 937: DANCE THEATRE

\$34,325

ACDA festival, costumes, sets, lighting, sound equipment, student workers, videographer, performances, professional guest choreographers, student workers, and masterclasses. Free tickets for students.

A 10% cut would give us \$30,893 of funding. This would:

- Reduce the funding to bring in a guest choreographer
- Limit the amount of programming for concerts by reducing our ability to build lights, sets, and sound

A 15% cut would give us \$29,176 of funding. This would, in addition to a 10% cut:

- Limit our ability to purchase and make new costumes
- Cut the funding to attend the ACDA festival

A 20% cut would give us \$27,460 of funding. This would, in addition to a 10% & 15% cut:

- Limit our ability to upkeep equipment such as lighting, sound, and stage materials
- Limit our ability to hire a photographer and create necessary publicity materials

A 10% cut would give us \$80,106 of funding. This would:

- Limit our programming by reducing our royalties budget
- Reduce our S&S budget resulting in smaller sets, reduction in new costuming, and props
- Limit our ability to travel to ACTF if it is held out of state

A 15% cut would give us \$75,656 of funding.

This would, in addition to a 10% cut:

- Reduce our publicity and marketing budget
- Reduce our ability to hire additional stitchers or costume shop attendants

A 20% cut would give us \$71,206 of funding. This would, in addition to a 10% & 15% cut:

- Reduce student hours in the shop due to creating much smaller sets
- Limit our ability to replace tools, stage materials, and lumber/fabric needed for shows



CAD 938: THEATRE

\$89,007

Student workers, theatre festivals and conferences, professional guest artists, royalties, and performances. Free tickets for students.



CAD 939: SUMMER THEATRE

\$33,767

Student workers, professional sets, costumes, guest artists, community members, Shakespeare, and performances.

Free tickets for all.

A 10% cut would give us \$30,390 of funding. This would:

- Reduce the funding for guest artists
- Reduce the budget for S&S resulting in smaller sets

A 15% cut would give us \$28,702 of funding. This would, in addition to a 10% cut:

- Limit our advertising and community outreach
- Reduce our ability to create new costumes and reduce the budget for our costume designer

A 20% cut would give us \$27,013 This would, in addition to a 10% & 15% cut:

- Reduce student hours in the shop due to creating much smaller sets
- Limit our ability to replace tools, stage materials, and lumber/fabric needed for shows

A 10% cut would give us \$10,800 of funding. This would:

- Reduce the funding to upkeep period instruments and other equipment
- Reduce programming for shows by limiting our sheet music budget

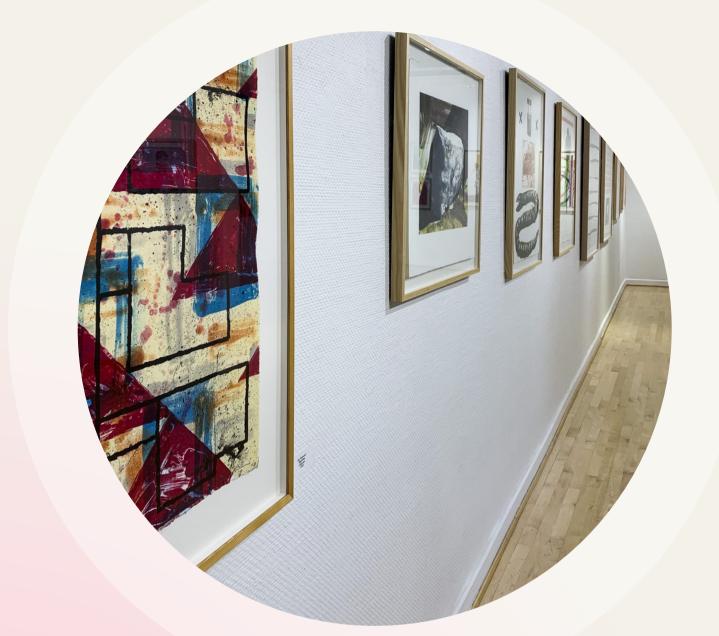

Free for all.

A 10% cut would give us \$14,000 of funding. This would:

- Reduce the funding for guest artists
- Limit the programming in the art gallery, reducing cultural experience

A 15% cut would give us \$13,222 of funding. This would, in addition to a 10% cut:

- Limit the ability to upkeep gallery equipment and postage for shipping materials
- Limit the budget for community outreach and publicity
- Cut the funding for refreshments during gallery openings

A 20% cut would give us \$12,444 of funding. This would, in addition to a 10% & 15% cut:

- Reduce the need for student workers by reducing the amount of shows we can hang
- Cut the funding for 1 gallery exhibit
