# 6.1. IFC Revenue Projection Memo

Darin Silbernagel hands out the 2015-2016 Incidental Fee Revenue Projection memo. Maintaining the, recommended, ten percent in the reserve should be attainable. He also notes that enrollment numbers are 331 less than projected.

While it was previously stated that the fee could be decreased \$14 (based on base budgets) it appears a \$4 increase is needed; mainly due to enrollment numbers.

## 6.2. Administrative Overhead Study

The administrative overhead study is conducted every two years; Darin has the twenty seven page study if anyone wants to review it. The current administrative overhead for IFC funded areas is 7%; the study results recommend increasing it to 7.63%. Darin's recommendation to the administration was to increase it to 7.4% instead.
