1. Welcome

- **Update on NWCCU accreditation**

Associate Provost Judy Sylva provided an update on the completion of the Year 7 Peer-Evaluation Report following the site visit from Northwest Commission on Colleges and Universities (NWCCU) April 12-14, 2023. She thanked the Council for their participation in preparing the report. She noted receiving feedback from peers is a valuable tool to help us understand what we are doing and where we have room for improvement.

- **Vision for the results of this planning process**

- Judy shared the Planning Team's working document for [creating a shared language for the next cycle of WOU strategic planning](#).
- **Vision for the next plan:** The vision for this round of planning is to define strategic goals. For each goal, institutional metrics and outcomes will be identified to evaluate the results and the impact of strategic initiatives. Specific strategic initiatives will be identified and implemented by organizational units and evaluated. The assessment of the impact of these initiatives will inform the assessment of aligned institutional outcomes. This process will empower and enable all units to make evidence-informed decisions, identify areas for improvement, and refine future initiatives to align with the institutional goals and associated outcomes.

Chelle Batchelor walked the group the process that the team has taken to identify evidence for each strategy or initiative listed for one of the Institutional Priorities.
