INVITATION TO BID #2021-09 CAMPUS DRIVE – DAN O'BRIEN WAY TRAFFIC ROUNDABOUT RESPONSE TO CLARIFYING QUESTIONS TWO July 15, 2021

Note that these are questions submitted by interested firms to this solicitation. The below answers are for clarification purposes only and in no way alter or amend the BID as published.

1. It was stated on pre-bid date of July 1, 2021 that Kittelson would release the electronic finish grade design files by the following Tuesday after the holiday, is that still going to occur?

ANSWER: Kittelson and Associates has provided the updated link to those files, files can be accessed at CAD and Surface Files - FOR BIDDING PURPOSES ONLY

2. Per clarifying questions on July 2, 2021, it states that the SB 5721 does apply to the project, can Oregon Tech clarify what subcontract level this requirement starts at? (ie. \$200k+)?
ANSWER: As stated in SB 5721 the subcontract level starts at \$200,000.00, further information can be access at the following site

- 3. Can the bid formed be consolidated to be fewer items, 77 items is very extensive for this size / scope of project, even if broken into the subsections highlighted in blue this would be helpful for expediting Contractor's ability to submit a timely bid? ANSWER: The bid form has been modified to remove line item no. 77, and there is now a total of 76 line items. The update bid form is attached as Exhibit A.
- 4. Can you verify the start date that is August 2, 2021 with completion date is stated for September 30, 2022; or if Contractors elect to not use flaggers, what is the start date allowed in 2022?
 ANSWER: Work in 2022 can begin the Monday following commencement (June 13, 2022?), with completion dates as specified.
- The bid schedule shows Item 77 1" Copper Water Service Line 50 LF. Can you please identify where this gets installed on the plans?
 ANSWER: Item No. 77 has been removed from the bid form, and no longer applies to the project. Please refer to attached Exhibit A for updated bid form
