INVITATION TO BID #2021-11 INTEGRATED STUDENT HEALTH CENTER (ISHC) – MECHANICAL/ELECTRICAL UPGRADES ADDENDUM NUMBER ONE September 1, 2021

On August 18, 2021, the Oregon Institute of Technology ("Oregon Tech") published Invitation to Bid #2021-11 for Integrated Student Health Center (ISHC) – Mechanical/Electrical Upgrades ("BID"). Oregon Tech has found that it is in its interest to amend the BID through the issuance of this Addendum Number One. Except as expressly amended below, all other terms and conditions of the original BID and subsequent Addenda shall remain unchanged.

- 4. Final Completion Date shall be amended from December 1, 2021 to <u>August 30, 2022</u>.
