The course will provide participants with:

- An understanding of Alaska native culture, and the influences of individual and public safety sub-cultures;
- Strategies for addressing Village public safety stress and health & wellness challenges
- Strategies for using bases of power to strengthen the role of village public safety in working in Alaska Native Villages;
- An understanding of how to build relationships and cooperative village public safety capabilities;
- Specific instruction in the technology enhanced village public safety simulator designed to assist village public safety in partnerships/team building, problem solving, ethical decision making and in developing collaboration to create and build sustainable Alaska Native focused and centered partnerships.

Who should attend? The target audience for this program is Village Public Safety and their tribal and non-tribal partners representing a broad spectrum of tribal, federal, state, and local jurisdictions within a region, including the following established disciplines:
